## RELEASE, WAIVER OF LIABILITY AND HOLD HARMLESS AGREEMENT

1. In consideration for receiving permission to participate in the APWA TEXAS CHAPTER EQUIPMENT ROADEO on February 8, 2018, I hereby release, waive, discharge and covenant not to sue APWA, the Texas Chapter, the La Torretta Lake Resort & Spa, its officers, servants, agents and employees (hereinafter referred to as "releases") from any and all liability, claims, demands, actions and causes of action whatsoever arising out of or relating to any loss, damage or injury, including death, that may be sustained by me, or to any property belonging to me, whether caused by the negligence of the releases, or otherwise, while participating in the APWA TEXAS CHAPTER EQUIPMENT ROADEO, or while in, on or upon the premises where the ROADEO is being conducted, while in transit to or from the premises, or in any place or places connected with the ROADEO.

I am fully aware of risks and hazards connected with being on the premises and participating in the ROADEO, and I am fully aware that there may be risks and hazards unknown to me connected with being on the premises and participating in the ROADEO, and I hereby elect to voluntarily participate in the ROADEO, to enter upon the above-named premises and engage in activities knowing that conditions may be hazardous, or may become hazardous or dangerous to me and my property. I voluntarily assume full responsibility for any risks of loss, property damage or personal injury, including death, that may be sustained by me, or any loss or damage to property owned by me, as a result of my being a participant in the ROADEO, whether caused by the negligence of releases or otherwise.

I further hereby agree to indemnify and save and hold harmless APWA, the TEXAS APWA CHAPTER, and the La Torretta Lake Resort & Spa from any loss, liability, damage or costs they may incur due to my participation in the ROADEO, whether caused by the negligence of any or all of the releases, or otherwise.

4. It is my express intent that this Release shall bind the members of my family and spouse, if I am alive, and my heirs, assigns and personal representative, if I am deceased, and shall be deemed as a Release, Waiver, Discharge and Covenant Not to Sue the above-named releases.
